I hope you are having an enjoyable summer break and are not too nervous of the impending GCSE/GCE results. I am optimistic that students have all achieved an excellent set of results that reflects their efforts and commitment.

Here are the arrangements for the publication and collection of **all** qualification grades:

- **AS/A Level & BTEC L3** results (for Y12 and Y13) will be available to students on **Thursday 15<sup>th</sup> August** from **08:00 am** to **10:00 am**.
- **GCSE & BTEC L2** results will be available to students on **Thursday 22<sup>nd</sup> August** from **08:30 am** to **10:30 am**.
- Students need to collect their own results and in person. No results will be given over the telephone or to a friend. However, results can be issued to an adult who has a signed consent form; the form is at the end of this letter, must be fully completed and must be signed by both the student and his/her parent/carer. The nominated adult must produce their own photographic ID before results will be released to them.

ALL GCSE/AS/A Level results are issued on a provisional basis. They may be subject to amendment by an awarding body, for example through the published post-results services, prior to the issuing of certificates.

All students in Year 11 who have conditional offers or have applied to join our Sixth Form are expected to attend the **Sixth Form enrolment day** to confirm their place. This takes place once they have collected results on **Thursday 22<sup>nd</sup> August** from **08:30 am** to **11:00 am**. Students not able to attend this enrolment day must contact us at [sixthform@keshacademy.com](mailto:sixthform@keshacademy.com) to make alternative arrangements.

Students in Year 11 who are still unclear about what to do after receiving their GCSE results, should also attend the enrolment day on **Thursday 22<sup>nd</sup> August** from **08:30 am** to **11:00 am** to access support and guidance on the options available to them.

Last but not least, I would urge all students in Year 11 whose GCSE results may not meet the entry requirements for their chosen Sixth Form courses to attend the enrolment day. They will be able to discuss alternative options and the support the Academy is able to offer.
